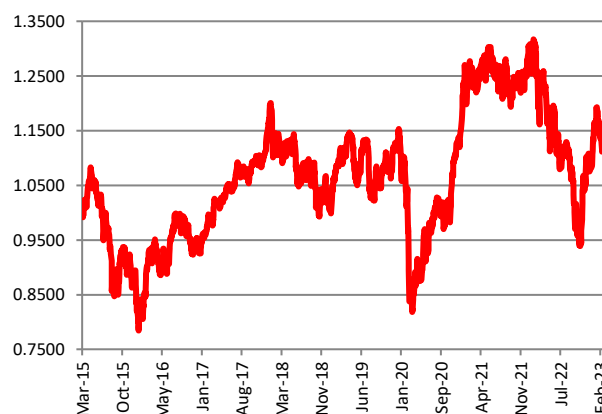
### Market Commentary

Asian equities ended the month down in February, following the strong performance in January. The correction occurred amid re-escalated US-China tensions and delayed Fed pivot, despite the recovery in manufacturing activities in China. Technology and communication services outperformed over the month, while utilities and energy detracted. MSCI Asia Pacific ex-Japan Net Index returned -6.8% for the month.
